- (b) Minimum 03 yrs experience as special educator preferably at any Primary School.

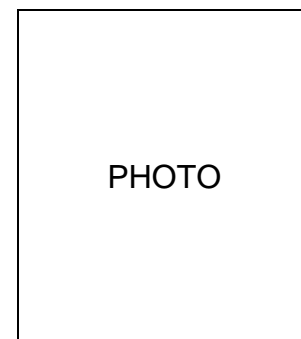
